Main Tax Revisions Coming into Effect from FY 2024

■New Forest Environment Tax (National Tax)

From FY2024, anyone with an address in Japan will be required to pay the forest environment tax. $\S 1,000$ will be taxed on a per-capita basis, in junction with the municipal and prefectural inhabitants tax.

To acquire funds for disaster preparedness programs in the wake of the Great East Japan Earthquake, a special surtax of $\frac{1}{2}$ 1,000 had been added to inhabitants tax ($\frac{1}{2}$ 500 for municipal+ $\frac{1}{2}$ 500 for prefectural). This surtax will end in FY2023.

The total amount remains ¥5,500 for both FY 2023 & 2024

■Unification of taxation methods for dividend income and capital gains derived from listed shares

Until now, tax payers have been able to choose different taxation methods for inhabitants tax and income tax levied on dividend income and capital gains derived from listed shares. However, from FY 2024, the taxation methods for income tax and inhabitants tax will be unified.

This means that the taxation method you choose for income tax will also apply to your inhabitants tax, possibly influencing your eligibility for nontaxation, and dependency/spousal exemptions. Be sure to carefully deliberate about the taxation method you choose when submitting your tax declaration.

The taxation method may also influence your national health insurance, elderly medical care insurance, and nursing care insurance calculations, or other government services, so please exercise care in choosing.
